## **Benefits of Licensing**

- Licensed pets are more likely to be reunited with their owners if they become lost. A license provides proof of ownership.
- The licensing fee goes directly to help stray and homeless animals and eliminate animal cruelty in our community.
- California Health and Safety Code (121690) requires all dogs to be vaccinated against rabies and to obtain a license:
  - Within 30 days after reaching the age of four months, or; within 30 days of acquiring the dog, or; within 30 days after entering the jurisdiction.

## **Steps to License**

- Proof of a current California-approved rabies vaccination is required for licensing. The primary rabies vaccination is good for one year. The second vaccination is given one-year later. Subsequent (or booster) vaccinations are valid for three years.
- Proof of alteration (i.e. spay/neuter) is not required, but will lower the cost of your dog's licensing fee by 50% or more.
- For your convenience, licensing can be completed online, in person or by mail. See back of brochure for details on each option.
